Subject: Regs4Ships Ltd publication Licence

I refer to your application for renewal of your licence to use the Merchant Shipping Legislation of the Republic of Cyprus and Circulars of the Department of Merchant Shipping (*hereinafter "the Department"*) which are accessible on the Department's website, in both your subscription website and CD-ROM product and wish to inform you as follows:

1. The Department hereby renews the Licence granted to Regs4ships Ltd to publish, in a subscription website and CD-ROM, the following (*hereinafter cited together as "the Department's material"*):
 - a. The consolidated and translated into English Merchant Shipping Legislation of the Republic of Cyprus which is available on the Department's website; and
 - b. The Circulars of the Department that are available on the Department's website.
2. The above Licence is renewed subject to the following terms and conditions:
 - a. The Licence is not exclusive, therefore the Department reserves the right to publish the material itself and to licence others to do so;
 - b. The material shall be published as it appears on the Department's website and its format, content and appearance shall not be modified for any reason whatsoever without the prior written consent of the Department;
 - c. Regs4ships Ltd shall incorporate in its subscription website all updates, additions and amendments to the Department's material within 3 (three) weeks from the posting of such update, addition or amendment on the Department's website or receipt of notification to this respect by the Department;



- d. When reissuing the CD-ROM product, Regs4ships Ltd shall include therein the material with all its updates, additions and amendments and shall stipulate the following wording:

“The reproduction (or production in case of the first CD-ROM) of this CD-ROM is licensed by the Department of Merchant Shipping of the Ministry of Communications and Works of the Republic of Cyprus”

- e. The assignment of the Licence is not permitted;
- f. Regs4ships Ltd shall provide, free of charge, five (5) usernames and passwords for full access to its entire website;:
- g. Regs4ships Ltd shall provide the Department, free of charge, two (2) copies of its CD-ROM product and of all updates.
3. The present Licence is valid for four (4) years and is subject to renewal at the request of Regs4ships Ltd.
4. The Licence shall be automatically terminated upon breach of any of its terms or conditions.
5. The Department may, at any time, withdraw the Licence provided it gives Regs4ships Ltd a notice of six (6) months.
6. The Department may amend any of the terms and conditions of the present Licence if deemed necessary and shall notify Regs4ships Ltd to this respect.
